## GUIDELINES ON THE APPLICATION OF THE IMO INTERNATIONAL SAFETY MANAGEMENT (ISM) CODE

### FOURTH EDITION



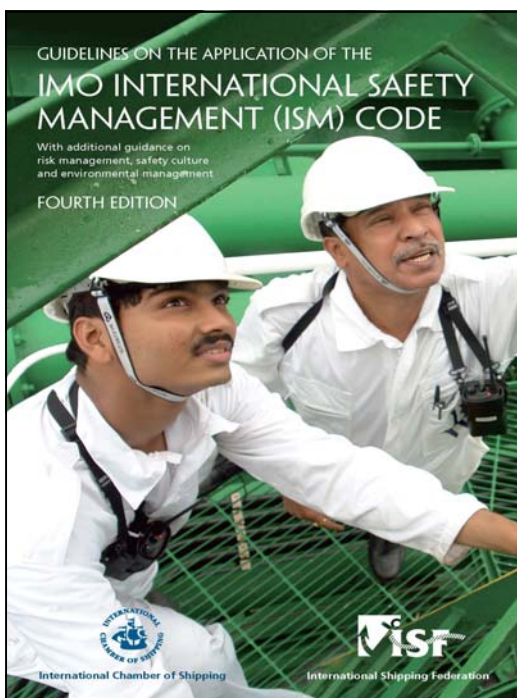
The definitive industry guidelines on the ISM Code are being fully updated to take account of the latest IMO amendments and guidance, and experience gained by industry since the Code became mandatory. The fourth edition will supersede the previous 1996 edition.

As well as containing updated advice on the application of ISM requirements, the new edition will include expanded guidance on:

- Maintenance of effective Safety Management Systems
- Role of the Designated Person Ashore (DPA)
- Risk management
- Safety culture
- Environmental management

To provide additional utility, the new edition will be accompanied by a **CD version** of the text with a “search” function, and various reference documents including a model Ship Energy Efficiency Management Plan to reduce fuel consumption and CO2 emissions.

The Guidelines will also take account of developments such as amendments to the STCW Convention, the ILO Maritime Labour Convention and new environmental regulations.
